- A Notice of Agreement of Each Entrant must be completed by each entrant.

- Receipt of entry will be acknowledged by e-mail. It is the exhibitor's responsibility to confirm receipt of entry with the Test Secretary if an acknowledgement has not been received within 48 hrs of submission.
- Entries received prior to Entry Open or after Entry Close will be discarded.
- Entries withdrawn after Entry Close must still pay the appropriate fees, unless the vacancy is accepted by an Alternate.
- A random drawing of all valid entries will take place on September 4, 2024 at 8:00 pm at the Test Secretary's address to determine placement in the test or on an Alternate list.

- Subject to entries received, volunteer resources, and test site conditions, TD tracks are planned to occur on Saturday September 14th and TDX tracks are planned to occur on Sunday September 15th.
- The draw for tracks will occur at 7:30 am each day at the test location.
- Bitches in season will be allowed to participate, provided the Test Secretary is notified prior to the draw for tracks. Bitches in season will be assigned the last track.
- All exhibitors must be familiar with and adhere to the current CKC Tracking Test Rules & Regulations during the test: https://www.ckc.ca/en/Files/Forms/Shows-Trials/Event-Rules-Regulations/Tracking-Test-Rules-and-Regulations-January-2023
- CKC Tracking Test Rule 14.7: It shall be the duty and obligation of the test-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules, is not subject to indignities of any kind. The Tracking Test Committee Chair shall promptly report to the CKC any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.
- <u>CKC Tracking Test Rule 6.1.9</u>: Exhibitors may not train on the tracking fields within 10 days of the test.
- Dogs must be kept on leash and under control at all times, if not securely confined.
- Absolutely no open fires or smoking on the test grounds.
- Please clean up after yourself and your dog! Help us leave no trace at the test grounds ©

NOTICE OF AGREEMENT OF EACH ENTRANT

In consideration of the acceptance of my/our entry(ies) and of the holding of the test and of the opportunity to have the dog tested, I/we acknowledge and agree as follows:

- 1) The German Shorthaired Pointer Club of Canada (GSPCC) may refuse any entry for just cause, which the GSPCC deems to be sufficient.
- 2) Field Tracking Tests have certain inherent dangers associated with them, and as such any person participating in the test or being present on the test grounds assumes the associated risks.
- 3) To hold the Canadian Kennel Club (the "CKC"), any CKC approved judge, the GSPCC, its members, directors, officers, agents, committee members, test secretary, test chair, event volunteers at the test, and the landowners of the test grounds and any employees of any of them (collectively, the "Club"), harmless from:
 - a. Any claim for loss or injury which may be caused or alleged to be caused directly or indirectly to any person or thing by any act of any dog I have entered in the test, or am responsible for, while in or upon the test grounds, or near any entrance to the test grounds;
 - b. Any claim for loss of any dog I have entered in the test, or am responsible for, by disappearance, theft, death or otherwise, and from any claim for damage or injury to the dog, whether the loss, disappearance, theft, damage or injury is caused or alleged to be caused by the negligence of the Club or any other person or any other cause or causes;
 - c. For bodily injuries, including death at any time resulting from bodily injuries, sustained by any person or persons, including myself/ourselves, any minors for whom I/we is or are responsible or on account of damage to property arising out of or in consequence of my/our or their participation in the test or presence on the test grounds, however such injuries, death or damage to property may be caused and whether or not caused or alleged to be caused by negligence of the Club or any of them or any other person; and
 - d. I/we personally assume all responsibility and liability for any such claim; and
 - e. I/we further agree to assume the sole responsibility for and agree to indemnify and save the Club harmless from any and all losses and expenses (including legal fees) by reason of the liability imposed by law or a court of competent jurisdiction upon the Club or any of them for any of the foregoing.
