**DRAWING at 9:00 am on Monday April 14, 2025**

- Entries will be limited to number of dogs able to run during daylight hours
- Entries may close prior to Wednesday April 13th at 6:00pm, if full.
- Entries withdrawn after closing must still pay the appropriate fees. Failure to do so, will be considered “outstanding” payment.
- Running order draw will take place at the home of the Test Secretary and will be published after drawing
- The order & time of tests will be determined once entries close. The drawing will be “random”, and specific times cannot be assigned.
- The GSPCC reserves the right to rearrange the running order of the stakes, should conditions warrant
- First two dogs to be run each day will be notified by phone or email
- It is the responsibility of entrants to confirm receipt of their entries
- Bitches in season will only be permitted to run at the end of each test. The Test Secretary must be notified prior to the start of each test, or the run will be forfeited.

\* Listing Fee: A listing fee as established by the CKC must accompany the entry of a dog for which a CKC Individual Registration Number, Event Registration Number (ERN), Performance Event Number (PEN) or Miscellaneous Certification Number (MCN) is not shown on the entry form.

\*Fees are payable in Canadian funds.

**EVENT REGISTRATION NUMBER (ERN#):** Effective January 1, 1992 all dogs that are foreign born and foreign owned and enter Canada for the sole purpose of entering CKC events will no longer require a CKC Registration number, but will require an Event Registration Number (ERN#). **NOTE: WATER TEST RULES & REGULATIONS Section 17**

**It shall be the duty and obligation of the test-giving club to see that a judge, club official, volunteer or competitor at a Pointing Water Test is not subject to indignities. The Water Test Committee Chair shall promptly report to the CKC any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.**

**OTHER RULES:**

- Please arrive 30 minutes prior to each test to check in.

- No dog shall be picked up during a test except with permission from the judge.
- Collaring is permitted only as allowed with the permission of the judge for in the CKC Field Dog & Water Tests Rules & Regulations for Pointing Breeds (Effective January 1, 2020).
- Tracking Collars: Approved electronic collars that are designed for tracking only may be used. Any questions regarding their use should be referred to the Field Test Chairman. Collars must be approved by the judges before a dog commences running a test.
- No dogs off leash unless as part of a test, or directed by an event committee member. This is a working ranch with livestock and wildlife.
- No training of dogs on the grounds during the tests or at any time without the permission of the Test Chair.
- Current record of vaccination may be required.
- Bring drinking water for yourself and your dogs. No meals or refreshments will be provided at this event.
- Only designated people are to use Cwyn Mawr Ranch ATVs for the running of this event. These ATVs are being generously provided by the landowners for the event!
- Absolutely no open fires or smoking.
- No firearms are permitted at this event.
- Clean up all garbage and please use designated porta-potti's. We are thankful to Cwyn Mawr Ranch for allowing the use of their land!

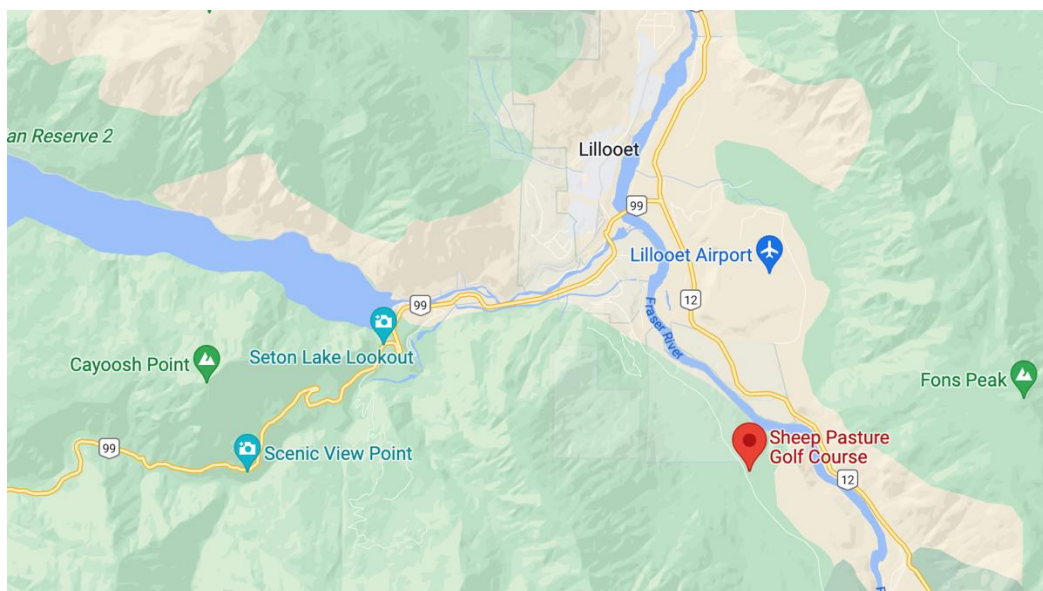

## **NOTICE OF AGREEMENT OF EACH ENTRANT**

In consideration of the acceptance of my/our entry(ies) and of the holding of the test and of the opportunity to have the dog tested and to win ribbons or trophies, I/we acknowledge and agree as follows:

- 1) The German Shorthaired Pointer Club of Canada (GSPCC) may refuse any entry for just cause, which the GSPCC deems to be sufficient.
- 2) Field and Water Tests have certain inherent dangers associated with them, and as such any person participating in the test or being present on the test grounds assumes the associated risks.
- 3) To hold the Canadian Kennel Club (the "CKC"), any CKC approved judge, the GSPCC, its members, directors, officers, agents, committee members, test secretary, event volunteers at the test and the landowners of the test grounds and any employees of any of them (collectively, the "Club"), harmless from:
  - a. Any claim for loss or injury which may be caused or alleged to be caused directly or indirectly to any person or thing by any act of any dog I have entered in the test, or am responsible for, while in or upon the test grounds, or near any entrance to the test grounds;
  - b. Any claim for loss of any dog I have entered in the test, or am responsible for, by disappearance, theft, death or otherwise, and from any claim for damage or injury to the dog, whether the loss, disappearance, theft, damage or injury is caused or alleged to be caused by the negligence of the Club or any other person or any other cause or causes;
  - c. For bodily injuries, including death at any time resulting from bodily injuries, sustained by any person or persons, including myself/ourselves, any minors for whom I/we is or are responsible or on account of damage to property arising out of or in consequence of my/our or their participation in the test or presence on the test grounds, however such injuries, death or damage to property may be caused and whether or not caused or alleged to be caused by negligence of the Club or any of them or any other person; and
  - d. I/we personally assume all responsibility and liability for any such claim; and
  - e. I/we further agree to assume the sole responsibility for and agree to indemnify and save the Club harmless from any and all losses and expenses (including legal fees) by reason of the liability imposed by law or a court of competent jurisdiction upon the Club or any of them for any of the foregoing.
